Dextra Orange is a Cosmetic Product which contains: Aqua, C9-11 Pareth-3, PPG-4 C13-15 Pareth-15, Glycerin, Perlite, Cocamide DEA, Sodium Hydroxide, Carbomer, Citrus Aurantium Dulcis Extract, C.I. 19140, C.I. 16035, Methylchloroisothiazolinone & Methylisothiazolinone.
